**Glossary**

**Espionage**, treason and espionage is expressed in the program, as well as the collection, stealing or possession with intent to transfer to a foreign state, foreign organization or their representatives information constituting a state or military secrets, as well as delivering or picking up a foreign intelligence service to other information for use them to the detriment of the Republic of Kazakhstan

**Health of the population** - a combination of public relations, to provide safe conditions normal organism of many people.

**Treason** - is expressed in the act of betrayal, ie providing citizen of Kazakhstan to a foreign state, foreign organization or their representatives in hostile activities against the Republic of Kazakhstan.

**Theft** - an uncompensated seizure and (or) treatment of other people's property in favor of the perpetrator or for the benefit of others. That uncompensated seizure of another's property entails damage to the owner or other owner of the property.

**Gratuitousness** - Free acquisition of another's property, that is, without compensation, without the equivalent of the cost.

**Commercial bribery** is - illegal transfer of a person discharging managerial functions in a commercial or other organization, money, securities or other property, as well as the illegal provision of the property-related services for the use of his or her position in the interests of the person performing bribery (1 Article . 231 of the Criminal Code) and illegal receipt of the person performing managerial functions in a commercial or other organization, money, securities and other assets, as well as use of property-related services for the use of his official position in the interests of the person performing bribery (Part 3 Art. 231 of the Criminal Code).

**Pesticides, chemicals** to control weeds (herbicides), pests (insecticides, etc.), diseases of crops, trees and shrubs, grain (fungicides, etc.);

**Fertilizers** - organic and mineral substances containing elements of plant nutrition and used to improve soil fertility (nitrogen, phosphate, etc.);

**Plant growth stimulants** - natural, synthetic substances, promote cell division, or stretch them;

**Environmental crime** - it is socially dangerous acts that infringe on the social relationships underpinning established in Kazakhstan environmental law and order, environmental safety of society, and cause harm to the environment and human health, the responsibility for which is provided in the articles of Chapter 11 of the Criminal Code.

**Under attack** - means any action designed to achieve results through the application of criminal violence against the victim, or a real threat to its immediate application.

**Social morality** - it developed the spiritual and moral qualities necessary for people in the community, as well as the implementation of these rules of conduct.

**Terrorism** - is completed crime from the moment of the explosion, arson or other actions that create a real threat to people's lives, causing significant property damage, or other socially dangerous consequences.

**Organizational and administrative duties** is a duty (features) of the person in relation to managing a team, the production activity of individual workers, area of work (eg, selection and placement, scheduling, maintenance of labor discipline, etc.).

**Administrative functions** is the authority to manage and dispose of property of the organization, to allow for storage and control of its preservation, making transactions with respect to such property, money orders, etc.

**Violation of license terms mean** - activities not specified in the license, transfer the license to another person, business activity in before and after the expiration of the period specified in the license, etc.

**Creating a gang** - involves any action, which resulted in the formation of an organized stable armed group to attack citizens or organizations. For example, these actions are expressed in the conspiracy, the finding partners, acquisition, financing, etc.

**Create an armed gang** - the offense is consummated, regardless of whether they were committed to plan its crimes.

**Guide means gang** - decisions related to both the planning, material support and organizing gang activity, and the commission of specific attacks.

**Participation in the band** - is not only directly involved in attacks committed by it, but also the implementation of active gang members other actions aimed at financing, weapons, vehicles, Finding a target for attacks, etc.

**Participated in the attack** - as a form of banditry means that the person is not in a constant composition of the gang, is not a member, but is involved in a gang committed the attack.

**Major damage** - recognized the damage caused to an individual by an amount of one hundred times the monthly index (see the remark  $\neg$  to Article 189 of the Criminal Code). Income is recognized on a large scale income, the amount of which exceeds five hundred MCI.

**Readily admits** - in order to track down prey, persecution itself prey wild animals, birds, reptiles and amphibians that live in the wild.

**Commercial hunting** - is the taking of wild animals in order to obtain economically useful products, and professional and amateur sports to meet the athletic and aesthetic needs of the citizens and for the personal consumption of produced goods.

**The illegality of the transfer**, receipt of property means - that such action is either prohibited by law or the constituent documents of the organization, or, if not prohibited, but they can harm the interests of the organization, or does not correspond to the nature of the governing body, or are directed against the legitimate interests of the company or other organization.

**Illegal services** - any treatable legal property assessment in accordance with the law of gratuitous needs person that does not produce income, benefits or other benefits in a commercial or other organization in which the person bribed or managerial.
