Methodical instructions for conducting seminars.

To conduct seminars on the course of International Criminal Law that corresponds to the Curriculum and.

Plans for seminars on each topic developed by the course teacher on the basis of program provisions and approved at the meeting of the department. The task of preparing for each seminar is communicated to students at the conclusion of the lecture preceding the seminar and are reflected in the "Methodological Guidelines for Conducting Seminar Sessions"

Preparation for each 2-hour seminar provides 4 hours of independent work. It includes independent study and summary of legal sources and recommended scientific and educational methodical literature, finalizing the lecture notes, accomplishing practical tasks, solving legal problems, preparing scientific reports (reports), and other types of work according to the assignment received.

The workshop provides:

- a) Introductory part: checking the readiness of the group for the lesson, announcing the topic, purpose and order of the lesson. (10 min.)
- b) The main part: hearing reports, discussing issues, solving legal problems, testing, etc. (60 min)
- c) The final part: summing up the workshop, announcing the grades, the task to prepare for the next lesson (10 min)

The amount of material to be discussed for each seminar is determined by the department. The literature recommended for study and summary corresponds to the list of literature indicated in the work program of the course and is available in the library fund of the Institute in sufficient quantity for students. Additional literature can be used individually and from other sources, as well as from periodicals, statistical collections, collections of scientific articles, the Internet, etc.

The results of the work of students at the seminars are taken into account as an intermediate control over the quality of mastering the educational material.
