### **Criminal, legal, and criminological measures to combat crime of migrants**

In this article we consider criminal and legal and criminological measures of counteraction to the crimes committed by migrants. These measures represent the many-sided activity which is based on the criminal law, carried out by the subjects possessing powers on application of the criminal law. Now possibility of application among migrants of criminal and legal measures of the prevention of crimes, including, promotion of the criminal legislation, motivation of offenders to voluntary refusal of end of the begun crime and to active repentance decreased.

**Keywords:** Crime of migrants, the prevention of crime, prevention of a crime, evasion from registration, law enforcement agencies.

It is known that crime control represents set of measures economic, political (including legal), psychological, organizational, technical character which are directed to elimination of the factors promoting commission of crimes on the prevention, suppression, registration, disclosure (search of criminals) and investigation of crimes, on implementation of criminal justice, correction of the persons who committed a crime, and control of their behavior after serving sentence and also on compensation of negative consequences of crimes [1, page 697].

In this article we consider criminal and legal and criminological measures of counteraction to the crimes committed by migrants. These measures represent the many-sided activity which is based on the criminal law, carried out by the subjects having powers on application of the criminal law.

Treat the bases of application of measures of criminal and legal influence:

- crime execution;
- detection of real danger of crime execution (detection of intention on crime execution, preparations for a crime, attempted crimes);
- need of the criminal and legal prevention of crimes.

Criminal and legal influence, certainly, includes not only direct use of standards of the criminal legislation to the migrants guilty of crime execution. It assumes more wide range of elements which admit:

- criminal and legal measures of the prevention of crimes;

- criminal and legal measures of restraint of crimes (justifiable defense, infliction of harm during detention of the person who committed a crime, accountability for preparation or attempted crime, timely application of the criminal and legal bans);

- criminal and legal measures of realization of responsibility.

Addressing criminal and legal measures of the prevention of the crimes committed by migrants, we will list the main of them is a promotion of the criminal legislation, motivation of offenders to voluntary refusal of end of the begun crime, motivation of offenders to active repentance. Also include assistance of social adaptation of the persons who committed crimes in this group [2, page 29].

Traditionally, till 90th years of the last century, in our country criminal and legal measures of the prevention of crimes were implemented, first of all, at the place of residence of citizens and in the place of their work, by means of influence of labor collectives. However, for the last decade of the last century and the first years of a century present the anonymities expansion of accommodation of migrants and distribution of labor employment of migrants in a hidden economy became characteristic.

We agree with Babayev M.M. position and the Queen M.V. that impersonality and anonymity of life "of course, reduces
