# Methodical recommendations for the organization and conduct of independent work of students

## 1. General conditions of independent work of students of the university

- 1.1 These Guidelines for the independent work of students at the Al-Farabi Kazakh National University are developed in accordance with:
- p.35-36 of the Rules of the Organization of the Educational Process on Credit Technology of Education, approved by Order No. 152 of April 20, 2011, as amended on 02.06.2014 of Order No. 198.
- 35. The entire volume of the SRO is confirmed by assignments requiring the student daily self-employment.
- p. 6 of the Academic Policy of the KazNU named after Al-Farabi
- 6.1. In the context of credit technology training for students to fully master the educational program, a large amount of independent work is carried out, which is divided into two parts: independent work performed under the supervision of the instructor (SRSP, SRMP, SRDP), and the part that is performed completely independently.
- 6.2. Independent work under the guidance of the teacher is an out-of-class activity of the students, which is performed by him in contact with the teacher on a separate schedule, approved by the dean of the faculty. This type of work includes consultations on the most complex issues of the curriculum, homework, course projects (works), control of semester works, reports and other types of tasks for independent work.
- 6.3. All types of independent work are necessarily described in the syllabus and the UMKD with the indication of specific tasks, evaluation criteria and the schedule for submitting tasks.
- 6.4. The trainee may not be present in the classroom according to the schedule of the SRSP / SRMP / SRF, if the fulfillment of the tasks is not difficult for the individual. The presence of the teacher in the classroom for the duration of the time specified in the schedule of the SRSP / RCP / SRPA is mandatory. It is not allowed to replace the SRSP / SRAP / SRDP with seminars, practical or laboratory exercises.

- 1.2. The methodical recommendations were developed by the Methodical Department of the Kazakh National University named after Al-Farabi and are designed to ensure the independent work of students
- 1.3. The independent work of the student is an important component of the educational process aimed at improving the quality, depth and strength of the acquired knowledge when studying a specific discipline of the curriculum, forming the student's need for self-education, self-development and self-improvement, including in subsequent professional activities.
- 1.4. Planning of independent work of students is carried out through the development of appropriate teaching and methodological documentation of the faculty, department, each teacher, including scheduling the SRSP, scheduling the load of the teacher, developing the schedules of the CDS.
- 1.5. The independent work of students is coordinated by the dean's office, the department, the teacher who is doing the classroom work in this academic group.
- 1.6. The goal of independent work of the students of the university is the formation of cognitive independence and application of knowledge in practice. Under independence, you can consider both the organizational and technical side of the process, as well as cognitive and practical activities.
- 1.7. III Carrying out of independent work of studying university

#### 3.1 Forms of SROs

1 level (1-2 courses)

3.3.1 tasks - creative study of the material. Mastering concepts, facts, scientific problems, well-known scientific theories, laws.

Standard - to study 2 sources of information and write a conclusion of 300 characters

3.3.2 Teaching - a summary of the main thoughts of the material read.

Standard - write a thesis for 200 characters

3.3.3 Annotation - a brief collapsed statement, the contents of the reading without losing the existing meaning.

Standard-write an annotation of 150 characters

3.3.4 Drawing up the inquiry - the information received after the searches.

Standard - to study sources of information and write a 250-character certificate

3.3.5 Drawing up a formal-logical model-a verbal schematic image of what has been read.

Standard - to study sources of information and make a model

3.3.6 Creation of a thematic thesaurus is an ordered complex with a basic concept on a section, topic

The standard is to study the section and write the thesaurus of 20 concepts and their evolution

3.3.7 Drawing up a matrix of ideas - a comparison of the characteristics of homogeneous objects of phenomena.

Standard - to study the sources of information and write a matrix of 100-200 characters

3.3.7 Verification work - aims to clarify the level of knowledge of the student in this discipline (answer some theoretical questions or the presentation of the material should be problem-thematic).

Standard - to study different points of view of scientists, to generalize the material. The volume is 1-15 pages. Structure: introduction; consideration of the first question; consideration of the second question; practical task; conclusion; bibliography
