Espionage-Treason in the form of espionage is expressed in the transfer, as well as collection, abduction or storage with the purpose of transferring to a foreign state, foreign organization or their representatives information constituting a state or military secret, as well as the transfer or collection on the instructions of foreign intelligence of other information for use at the expense of the security of the Republic of Kazakhstan

Health of the population is a set of social relations that provides a safe condition for the normal functioning of the body of many people.

State treason - is expressed in an act of treason, i.e. rendering a citizen of the Republic of Kazakhstan assistance to a foreign state, a foreign organization or their representatives in conducting hostile activities against the Republic of Kazakhstan.

Theft - is a gratuitous withdrawal and (or) circulation of someone else's property in favor of the guilty party or in favor of other persons. It is the gratuitousness of seizing someone else's property that causes damage to the owner or other owner of the property.

Gratuitousness is the free acquisition of another's property, that is, without compensation, without the equivalence of its value.

Commercial bribery is - illegal transfer of money, securities or other property to a person performing administrative functions in a commercial or other organization, as well as unlawful rendering of services of a property nature for the use of his official position in the interests of the person carrying out bribery (Part 1, art. 231 of the Criminal Code of the Republic of Kazakhstan), as well as illegal receipt by a person performing administrative functions in a commercial or other organization of money, securities, other property, as well as the use of services of a property nature EPA for the use of his official position in the interests of the person carrying out bribery (Art. 3 of Art. 231 of the Criminal Code).

Pesticides - chemical preparations for control of weeds (herbicides), with pests (insecticides, etc.), with diseases of agricultural plants, trees and bushes, grains (fungicides, etc.);

Fertilizers - organic and mineral substances containing elements of plant nutrition and used to improve soil fertility (nitrogen, phosphate, etc.);

Stimulants of plant growth - natural synthetic substances, accelerating the division of cells or stretching them;

Ecological crimes are socially dangerous acts that infringe on public relations that ensure the ecological legal order established in the Republic of Kazakhstan, the environmental safety of the society, and that are harmful to the environment and

human health, for which responsibility is provided for in articles 11 of the Criminal Code.

Under the attack, one should understand actions aimed at achieving a criminal result by using violence against a victim or creating a real threat of his immediate application.

Public morality is the developed spiritual and spiritual qualities necessary for people in society, as well as the implementation of these rules of conduct.

Terrorism is considered to be a completed crime from the moment of the explosion, arson or other actions that create a real threat to the death of people, causing significant property damage or the occurrence of other socially dangerous consequences.

Organizational and administrative duties are duties (functions) of the person in the management of the collective, the production activities of individual employees, the work site (for example, the selection and placement of personnel, work planning, maintenance of labor discipline, etc.).

Administrative and economic duties

Violation of the licensing are the powers to manage and dispose of the organization's property, establish the procedure for its storage and control over its safety, make transactions in relation to such property, dispose of funds, terms means the performance of activities not specified in the license, transfer of the license to another person, engaging in business activities before and after the expiry of the term specified in the license, etc.

Creation of a gang - involves the commission of any actions resulting in the formation of an organized, stable armed group in order to attack citizens or an organization. For example, these actions are expressed in collusion, the search for accomplices, the acquisition of weapons, financing, etc.

The creation of an armed gang is an end to the composition of the crime, regardless of whether the crimes that it planned were committed.

Leadership of gangs means taking decisions related to planning, material support and organization of criminal gang activity, and the commission of specific attacks.

Participation in the gang - is not only a direct participation in the attacks, but also the performance by gang members of other active actions aimed at financing, providing weapons, transport, finding objects for attack, etc.

Participation in an attack - as a form of banditry means that individuals
