Final exam rules

Oral exam: traditional – answers to questions.

The exam format is oral. The platform for the examination on the discipline "History of State and Law of foreign countries" is ZOOM platform. The process of passing an oral exam by a student involves the automatic creation of an examination ticket, to which the student must answer orally to the examination committee. When conducting an oral examination, video recording is mandatory.

Schedule: The exam is held according to the schedule, which will be posted in advance in the Univer system, as well as communicated to the students by the faculty and department.

A link to the scheduled exam video conference will be sent on the day of the exam.

Exam rules: According to the exam schedule, the exam organizer - a teacher or a member of the examination committee, starts the ZOOM conference, sends invitations to participants and starts the exam. If the exam is accepted by the examination committee, the teacher includes the committee members in the student group chat in advance, so that the examiners can also remind students to start the exam in the general chat. After all the participants have joined the conference online, the teacher or member of the commission: 1. includes a VIDEO RECORDING of the exam; 2. welcomes the participants to the exam; 3. warns that video is being recorded; 4. announces the rules of the exam: 5 the order of the examinees, 6. time for preparation; 7. response time; 8. Grants permission to compose the theses of answers, if necessary, on paper in pen; 9. warns that the examinee will have to show the abstract sheet before starting the answer; 10. Allows other examinees to be on standby - not to be in front of the camera all the time, but not to leave the meeting; 11. announces the surname, name and patronymic of the examinee; 12. asks the examinee to show on a video camera an identity document (passport. IT IS FORBIDDEN to take an exam using an ID card) the room in which he is located - there should be no strangers in the room, additional sources of information (if possible by student); 13. warns about the prohibition of the use of additional sources of information; 14. The chairman of the examination committee calls the student's full name, asks him to turn on the screen demonstration, log into the IS Univer with his account, open the exam ticket and read the ticket questions; 15. The commission records the questions spoken by the student for follow-up questioning.

Duration of preparation time - 15 minutes; Time for answering - 15 minutes.

Policy of assessment: The scores obtained on the exam are carried over to the exam sheet. The teacher manually sets the score in the attestation sheet in IS Univer. Time for scoring is up to 48 hours. Exam results can be revised based on proctoring results. If a student violated the rules for passing the exam, his result will be canceled.
