FINAL EXAM CONTROL

The exam form is oral on the ZOOM platform.

Final control (exam) in the discipline criminal law of the Republic of Kazakhstan (special section) for 2nd year students, full-time part-time is held in the Zoom system in oral form. When passing this test, you must first familiarize yourself with all the requirements for this system. All instructions univ.kaznu.kz uploaded to the home page. It is forbidden to conduct an exam in oral form (Kahoot, Quizzlet, etc.). External services can be used during current classes, but not for exams. The exam is conducted in oral form only on the official information and educational platforms of the university: is Univer. Oral exam control - online proctoring. Proctoring technology (Engl. "proctor" - control over the course of the exam). Proctors, like the usual exam in the classroom, monitor the fair passage of Examiners' tests: they perform tasks themselves and do not use additional materials. The real-time exam on the internet can be monitored by a specialist (day proctoring) via a webcam and a program that tracks the subject's desktop, the number of people in the frame, extraneous sounds or voices, and even visual gestures (cyber proctoring).

The exam is taken by the teacher who conducts the lesson himself. Tickets are made by the deputy dean of UMVR through the Univer system. In order to successfully pass the exam in the discipline "Criminal law Republic of Kazakhstan Special part", the master's student must: - carefully study the course of study in accordance with the completed Program; - study additional literature on the topics of the course; - work with the conceptual and terminological apparatus for obtaining the concept of crime; - analyze the composition of criminal offenses against the individual. Rules for conducting the exam. When conducting an oral exam, the student must turn on the video recording. Before starting the oral exam, undergraduates must check: internet connection on the working device (computer, monoblock, laptop, • tablet), the device must be provided with charging for the entire duration of the exam; the suitability of the web operation of the camera and microphone. The teacher calls the name of the student to whom he is responsible. There should be no strangers in the room where it is located. It is forbidden to use additional sources of information the ticket provided by the dean's Office is displayed on the screen. There are 3

questions on the ticket. Final control issues necessarily include tasks that are considered in all types of classes (lectures, practical, PPR), as well as questions that are submitted to Midterm Exam. The time to prepare for the answer is 15 minutes. The response time is 15 minutes. If necessary, the student is allowed to write the answer theses on paper with a pen. Before answering, the examiner must present a sheet with abstracts. The student should always be in front of the camera. You can't turn off the camera. The rest of the examiners should be on standby—they should not be in front of the camera all the time, but should not leave the meeting. The graduate student must complete the exam in one ZOOM session. It is forbidden to start the response and complete the restart in one session. Pay attention. If a student who has opened his ticket for technical reasons (power outage, internet shutdown, or low speed) does not stay online for more than 10 minutes during the exam, then his answer is canceled. The exam is postponed to another day in coordination with the Department of academic affairs. After completing the answer, the student who passed the exam is allowed to leave the video

Required requirements for the student:

On the main page, where the student is posted with all the instructions univer.kaznu.kz get acquainted.

"ZOOM" should be enabled 5-10 minutes before the exam starts.

Preparation of the workplace for passing the exam. All offers

"univer.kaznu.kz" the system is indicated in the operating instructions.

The student should familiarize himself with the proctoring program, which controls the process of passing the exam.

An oral exam is held in this discipline.

Students are notified in advance of the exam date and time in the exam schedule in the university system.
