

General requirements for project work on the course.

The submitted project should have a cover page with the following information: surname, name, patronymic of the executor and the project leader (s), the title of the project, the year of writing the work, indication of the goals and objectives of the project work.

The content of the project work should include such sections as:

- introduction, which substantiates the relevance of the selected or considered problem;
- review of literature, scientific articles, works already done earlier on solving similar problems;
- place and time of work performance;
- a brief description of the methods used with references to their authors (if they are necessary for the work or used in it);
- systematized, processed research results;
- conclusions drawn after completion of the project;
- practical use of the project results;
- social significance of the project;
- an appendix: photographs, schemes, drawings, herbariums, tables with statistical data, etc.

CRITERIA FOR EVALUATING COURSE PROJECTS (EXEMPLARY):

- clarity of the set goal and objectives;
- thematic relevance and volume of literature used;
- validity of the chosen methods for conducting research;
- completeness of disclosure of the chosen project topic;
- validity of conclusions and their compliance with the objectives;
- level of presented data obtained in the course of research of the selected problem (object), their processing (if necessary);
- analysis of the obtained data;
- presence in the work of the conclusion or practical recommendations;
- quality of work design (availability of tables, charts, graphs, photo materials, sketches, list of used literature, herbarium materials for botany projects, etc.).

CRITERIA FOR EVALUATING THE SPEAKER'S PERFORMANCE AT THE PROJECT DEFENSE:

- validity of the structure of the report;

- highlighting of the main points;
- completeness of disclosure of the chosen research topic in the defense;
- use of visual and illustrative material;
- competence, erudition of the rapporteur (speaker) and his ability to quickly navigate in his work when answering questions. Asked by the commission (members of the jury or expert committee);
- the level of presentation of the project report (the ability to use the materials obtained during the research when presenting the report and answering questions), the clarity and
- clarity in answering all questions arising in the course of the report, which is an indispensable indicator of the independence of work on the chosen topic.

GENERAL REQUIREMENTS FOR THE DESIGN OF THE COURSE PROJECT:

In the design of the work should comply with a certain standard, it will allow in many ways, to limit the inclusion in the work of unnecessary materials of secondary rank, which will prevent the main thing, the main or clogging the work.

For the defense of the project can be submitted as a printed version, and in handwritten, designed on white heavy sheets of paper format A-4. All signatures should be clear and executed, preferably in printed font, as well as large enough and clearly readable. Paper size A - 4, margins (top - 2 cm, bottom - 2 cm, right - 1.5 cm, left - 3 cm). Details on design may also be specified additionally in the materials of the syllabus.
