Then, include a few sentences about the actors in movie. Your next step is to summarize the plot elements of the film: What are the critical things that happen, and how are they resolved? Some people like to include a summary of the themes or morals of a film. Then wrap up your summary with a sentence that pulls all of your ideas together about the film. Creativity in a summary is a good way to introduce new ideas and topics into a summary, but consider that it is more important to give accurate information than creative opinions and fillers.
